## What is Intensive Law & Trial?

The Intensive Law & Trial program provides an opportunity for high-achieving high school students with a passion for law to learn from pre-eminent legal professionals, including Stanford Law School professors.

While at the program, held at Stanford Law School in Palo Alto, CA over 10 days, students immerse themselves in the theory and practice of law through powerful skills workshops and real-world simulations. Students have the opportunity to develop essential skills such as making impactful opening and closing arguments, preparing cases, and readying witnesses for cross-examinations. The students' experience culminates at the San Francisco Superior Court, where they participate in a mock trial simulation, endorsed by the American Mock Trial Association.
