What is NYLF Law & CSI?

The National Youth Leadership Forum (NYLF): Law & CSI provides an opportunity for high-achieving high school students with a passion for law or forensic science to explore the entire judicial process, including custody, evidence, investigation, writing, and presenting a case.

While at the program, which is held in Washington, DC over six days, students enjoy hands-on experiences in the concentration of their choice (Law or CSI). They will navigate the legal process from the discovery of a crime, to collecting and analyzing all of the critical evidence, to preparing for the courtroom process, and ultimately taking part in the criminal trial simulation. During this time, students will take on the role of either a prosecutor, defense attorney, crime scene investigator, or a juror. Students will also participate in seminars led by law and forensic science experts, who will provide an inside perspective into the ethical dilemmas and challenges today's professionals face and what academic paths and skills are required for a law or forensics career.
